- 1. Revise the Personal Choice and Living Will Act. Passed House and Senate unanimously and has been signed into law.
- 2. Extend the Commission on Aging. Passed the House and Senate and has been signed into law.

Caregiver Support Maureen Henry summarized	The Special Committee on Caregiver Support has developed and published "Guidelines for Employers of Caregivers." (Send email to mhenry@utah.gov if you would like a copy of these documents.) This product is a comprehensive review of the issues and impact of caregiving in the workplace. The guidelines provide a step-by-step outline of actions employers may take to
	* survey staff to assess needs
	* evaluate policies and benefits applicable to caregivers in that particular workplace
	* suggestions for compiling an HR/EAP resource library about caregiving
	* availability of "brown-bag" training for employee caregivers; also benefit fairs to include issues of caregiving
	* suggestions for management training on caregiver employee issues, flexible work schedule
	These guidelines were presented to three area employers. These employers had expressed interest in evaluating their workplace as "caregiver-friendly" and taking the first steps of an incremental process to make "caregiver-friendly" a focus for employees.
	At this date, the Special Committee's task, development of the Guidelines, has been completed. At the next Committee meeting, further discussion will be given about publication of the Guidelines and/or presentation to the Special Committee on Seniors in the Workplace. The project is now ready for local AAA's Caregiver Support Programs to incorporate in their training and community education presentations. Planning for the publication of the Guidelines and implementation at the community level will bring the Committee's project to a close.

Alan Ormsby reported on the funding outcomes for DAAS, including increased ongoing funding for the Aging Waiver (\$340,000), Caregiver Support (\$300,000), Meals on Wheels (\$146,000), and a pilot transportation program.
