Welcome new appointees, Minutes Approval, Strategic Recap – Becky Kapp

Becky and Bette Vierra will meet with officials in the new Millcreek Township to see if we can get the Vial of Life program going.

Commission on Aging Activities

- a) Model Innovations in Long-Term Advance Care Planning Anne Palmer
 Reviewed activities performed under the Utah State Innovation Model planning activities with
 Avalon Nursing Homes and the Utah Health Information Network, where 800 POLST forms have
 not been uploaded and incorporated into residents' electronic health records. Outlined goals for
 creating a statewide POLST registry and attaining POLST Mature status wherein the goal would
 be to see that in appropriate settings POLST forms are completed 50% of the time.
- b) Age-Friendly Salt Lake City Anne Palmer
 What has occurred to further its commitment SLC met with the new staff of the new mayor. Dean Keith Diaz-Moore updated the staff and requested \$311,000, with support from SLC, U of U and possibly AARP. Air quality is an issue. Dr. Supiano involved in submitting a transformative excellence program and Professor/Dean of Architecture Diaz-Moore putting something together for Resiliency in Place.
- c) Financial Fraud Working Group Alan Ormsby (report presented by Nels Holmgren)
 Meeting monthly will present to the committee in June 2016. Trying to consolidate entities and looking at best practices in other states.
- d) The Conversation Project Kathleen Pitcher-Tobey Encourage the conversation (end-of-life) starter kit. Working with interfaith leaders. Starter Kits are available. Kathleen may present at the Area Agencies on Aging statewide meeting (U4A) so the materials can be disseminated through senior centers statewide.

Caregiver Voices in Theatre – Nancy Madsen

Partnership with U of U – Gerontology Researcher Jackie Eaton is looking for "out of the box" ideas to support caregivers – doing it through theatre. Jackie Eaton – meeting with caregivers in Davis, Summit

and Salt Lake Counties. "Portrait of a Caregiver" Play – what they are dealing with, a professional local theatre group will perform (4 performances) March 29th 11-12 Riverton Senior Ctr. April 4th for the community at the College of Nursing from 6-8p. How can we get the word out there? Recording a performance, citizens pages in Davis County. Digital publicity – invited to present in Washington DC.

Legislative Updates, including End of Life Options Act – All

Senior day at the Legislative – 200 to 250 Seniors 2/10/16 – they do have a voice. Triple A's caregivers support. Nels Holmgren– appropriations budget adjustment requests \$250,000 caregiver support and \$500,000 nutrition funding, not a lot of new funding this year. Pay for performance – Sorenson Foundation application is proceeding. Partner with U of U short videos – people receiving the help (Meals on Wheels).
